Sir/Madam,

In pursuance of the decision taken in the meetings of the Anti-Ragging Monitoring Committee and the Inter-Council Committee, you are requested to take action on the following lines:-

1. Update your website in the matter of anti-ragging besides giving publicity on anti-ragging through print, electronic and social media.

2. Use e-posters, social media, nukkadnataks, NSS, hoardings etc. to prevent ragging. Specific size and style of hoardings shall be as may be prescribed by the University Grants Commission.
3. Send admission brochures of your institution to the Monitoring Agency, University Grants Commission, New Delhi which will see that the anti-ragging provisios are adequately included therein.
4. Refer to UGC letter dt.11.6.14 as placed placed on PCI Website on 11.7.2014.
5. Impress upon the students to submit undertakings online instead of stamp paper affidavits. Copy enclosed for reference pls.
6. Intimate about the compliance of self-declaration.
7. Hold awareness campaign in the beginning of every academic session to educate the students about anti-ragging.
