I am directed to invite your attention to this Council's letters quoted above and to say that it has come to the notice of this Council that certain pharmacy institutions are expressing inability in providing space and details of the pharmacists to be engaged in the Jan Aushadhi Medical Store proposed to be opened in and around their premises. As per information made available to us, none of the pharmacy institutions has space constraint to the extent that it cannot provide a small space for opening a Jan Aushadhi Medical Store which is an important government programme aimed at providing medicines to the poor and needy population of the society at an affordable cost. Timely and speedy implementation of the Prime Minister's Jan Aushadhi Yojna hardly needs to be emphasized.
