

5. Mr. Somiran Sharma, learned counsel appearing for the Pharmacy Council of India, fairly states that the permission granted for the Academic Year 2022-2023 would be considered to be valid for the Academic Year 2023-2024.
6. In that view of the matter, the petitioners will have sufficient time to pursue the matter with their respective State Governments and the respective Universities for the

purpose of grant of permission and affiliation, respectively.

7. In view of the aforesaid statement, we direct the Pharmacy Council of India to grant fresh permission letter(s) granting them approval for the Academic Year 2023-2024.

8. In view of the above, these petitions are disposed of.

1. All these petitions arise out of peculiar facts and circumstances.
2. In view of the order passed by this Court in Misc. Application No. 2174 of 2022 in C.A. No. 9048 of 2012 titled as "Parshavanath Charitable Trust & Anr. v. All India Council for Tech. Education & Ors.", the Pharmacy Council of India was required to consider the cases of the institutions for grant of permission within a stipulated time period.
3. The cases of the petitioners were considered and they were granted permission for the Academic Year 2022-2023. However, on account of delay in deciding their cases, they could not get requisite permission from the State Government and the consequent affiliation from the respective Universities.
