Ministry of Human Resource Development has been collecting information through web based survey namely **All India Survey on Higher Education (AISHE)** on important parameters such as No. of teachers, Student enrolment, Infrastructure and Financial aspect from all institutions of Higher Education in the country. For the purpose of this Survey, Higher Education is defined as the education, which is obtained after completing 12 years of schooling or equivalent and is of the duration of at least nine months (full time) or after completing 10 years of schooling and is of the duration of at least 3 years. The education may be in the nature of General, Vocational, Professional or Technical education. The report of AISHE 2015-16 is available in website of Ministry of Human Resource Development i.e. mhrd.gov.in and report on AISHE 2016-17 will be available shortly.

2. List of institutions registered in AISHE portal is available at www.aishe.gov.in under the heading "Directory of Institutions" indicates that large number of institutions either have not registered or registered with incorrect name. MHRD is in the process of updating list of institutions of Higher education for collecting information for AISHE 2017-18. The AISHE 2017-18 will be launched by middle of December, 2017. The reference date for collecting of information for AISHE 2017-18 will be 30th September, 2017. Your cooperation is solicited for uploading correct and timely information on AISHE portal so that useful information on higher education may be collected.


