47.1 The latest information on record was placed.

47.2 It was noted that -

- i) institution is running D.Pharm course with 60 intake from 2019.
- ii) Inspection Report of September, 2021 reveals that –
  - a) against the prescribed requirement of 1 (Principal) + 7 (teaching staff), only 2 faculty members were present at the time of inspection.
  - b) Principal was not available.

- c) This clearly reflects that teaching staff and faculty cadre ratio as per prescribed norms was not appointed thus flouting the prescribed norms of “Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014”.
  - d) the infrastructural facilities like Laboratories, Lecture hall, equipments etc. are not as per the prescribed norms.
- iii) Institution was given an opportunity to appear before the Personal Hearing Committee (PHC) of the PCI on 13.12.2021. The findings of the PHC are as under –
- a) Principal was not appointed. Instead the ex-Principal who was serving elsewhere appeared before the PHC and signed the documents.
  - b) In mail dt.3.11.2021, the date of joining of Shri Om Prakash Kumar is indicated as 14.10.2021 whereas in documents submitted to PHC, the appointment letter dt.28.11.2021, his appointment is w.e.f. 28.11.2021.
  - c) teaching faculty appeared but they all were newly appointed.
  - d) the institution failed to submit proof of appointment / joining / payscales / salary details of faculty to PHC.
  - e) the photos submitted with respect to infrastructure are not Geo Tagged.
  - f) the lease deed has expired on 3.1.2018.
  - g) Institution also failed to submit proof of payment of purchase of equipments.
  - h) Similarly the documentary evidence in support of gas, water / electricity supply was not submitted.
- 47.3 In view of above, it was noted that the course of study of this institution does not continue to be in conformity with the statutory provisions of -
- a) Education Regulations, 1991 for the Diploma course in Pharmacy.
  - b) The Education Regulations, 2020 for Diploma Course in Pharmacy.
  - c) Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014.
- 47.4 Considering the above, it was decided to -
- a) reduce the intake capacity by 20 seats in D.Pharm course w.e.f. 2022-2023 academic session.
  - b) institution be advised to -
    - i) rectify the deficiencies pointed out in the September, 2021 inspection report and PHC.
    - ii) submit compliance with documentary evidence along with a copy of Income Tax Return in respect of Principal and all teaching faculty since inception of the course within 10 days of receipt of the communication from PCI.

48.2 It was noted that -

- i) institution is running -
  1. D.Pharm course with 60 intake from 2020.
  2. B.Pharm course with 100 intake from 2020.
- ii) Inspection Report of September, 2021 reveals that -
  - a) teaching staff appointed is less than prescribed.
  - b) This clearly reflects that teaching staff and faculty cadre ratio as per prescribed norms was not appointed thus flouting the prescribed norms of “Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014”.
  - c) the students are in 2nd year but laboratories are not available.
  - d) glassware and chemicals are deficient.
  - e) equipments are deficient.
  - f) exhaust fan and fuming cupboard are not available.
  - g) Library - the volume and titled were not as per the norms.
- iii) Institution was given an opportunity to appear before the Personal Hearing Committee (PHC) of the PCI on 13.12.2021. The findings of the PHC are as under -
  - a) the list of teaching staff submitted to PHC reveals that -
    - the courses were started in 2020 but 13 staff has joined in 2021.
    - date of joining in respect of 2 staff members is not indicated.
    - name of last employer in respect of 9 teaching faculty is not indicated.
  - b) experience of Principal and teaching faculty is not submitted.
  - c) the designation of the faculty was not mentioned.
  - d) the institution failed to intimate the payscales and salary of teaching faculty.
  - e) institution failed to submit any documentary evidence with regard to development of infrastructural as per the recommendations of the inspection report.
  - f) the photographs submitted with regard to infrastructure were not Geo Tag.
  - g) the institution also failed to submit payment proof with regard to purchase of equipments, chemicals, glass-wares etc. through bank.
  - h) Similarly no document proof for gas, water and electricity supply was submitted.
  - i) original attendance register of academic session was not produced before PHC.

- 48.3 In view of above, it was noted that the course of study of this institution does not continue to be in conformity with the statutory provisions of -
- a) The Bachelor of Pharmacy (B.Pharm) Course Regulations, 2014.
  - b) Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014.
- 48.4 Considering the above, it was decided to -
- a) reduce the intake capacity by 40 seats in B.Pharm course w.e.f. 2022-2023 academic session.
  - b) institution be advised to -
    - i) rectify the deficiencies pointed out in the September, 2021 inspection report and PHC.
    - ii) submit compliance with documentary evidence along with a copy of Income Tax Return in respect of Principal and all teaching faculty since inception of the course within 10 days of receipt of the communication from PCI.
- 48.5 Regarding D.Pharm course, it was decided to reiterate the earlier approval granted to D.Pharm course.

- 49.1 The latest information on record was placed.
- 49.2 It was noted that -
- i) institution is running D.Pharm course with 60 intake from 2018.
  - ii) Inspection Report of September, 2021 reveals that -
    - a) Teaching staff and faculty cadre ratio as per prescribed norms was not appointed thus flouting the prescribed norms of “Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014”.
    - b) furniture in Pharmacognosy laboratory was not provided.
    - c) the campus is not maintained properly. Overall dirtiness was observed.
    - d) equipments are deficient.
    - e) drinking water facility not available on the 2nd floor.
  - iii) Institution was given an opportunity to appear before the Personal Hearing Committee (PHC) of the PCI on 13.12.2021. The findings of the PHC are as under –
    - a) out of 7 faculty members name of last employer is not indicated in respect of 5.
    - b) the name of Mr.Gulistan appears on Council’s faculty portal but he did not appear before PHC. One of the faculty member Mr.M.P. Singh is over 65 years.

- c) no documentary evidence regarding appointment of Mr.Kunal Malik was provided.
- d) attendance register of faculty was not produced before PHC.
- e) salary to teaching faculty was not paid through bank.
- f) the photographs submitted with regard to infrastructure were not Geo Tag.
- g) payment details through bank transfer were not submitted for infrastructural facilities including furniture.

49.3 In view of above, it was noted that the course of study of this institution does not continue to be in conformity with the statutory provisions of -

- a) Education Regulations, 1991 for the Diploma course in Pharmacy.
- b) The Education Regulations, 2020 for Diploma Course in Pharmacy.
- c) Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014.

49.4 Considering the above, it was decided to -

- a) reduce the intake capacity by 20 seats in D.Pharm course w.e.f. 2022-2023 academic session.
- b) institution be advised to -
  - i) rectify the deficiencies pointed out in the September, 2021 inspection report and PHC.
  - ii) submit compliance with documentary evidence along with a copy of Income Tax Return in respect of Principal and all teaching faculty since inception of the course within 10 days of receipt of the communication from PCI.

50.1 The latest information on record was placed.

50.2 It was noted that -

- i) institution is running -
  - 1. D.Pharm course with 60 intake from 2019.
  - 2. B.Pharm course with 60 intake from 2020.
- ii) Inspection Report of September, 2021 reveals that -
  - a) teaching staff with M.Pharm qualification as prescribed under statutory provisions of “Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014” is not appointed i.e. teaching staff in terms of qualification is less than prescribed.

- b) This clearly reflects that teaching staff and faculty cadre ratio as per prescribed norms was not appointed thus flouting the prescribed norms of “Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014”.
  - c) equipments are deficient.
  - d) SOP of instrument use need to be prepared.
  - e) journals are to be subscribed.
- iii) Institution was given an opportunity to appear before the Personal Hearing Committee (PHC) of the PCI on 13.12.2021. The findings of the PHC are as under -
- a) The institution was asked to appear along with Principal and teaching faculty. However, no teaching faculty appeared before the PHC.
  - b) the names of said faculty members do not tally with the teaching staff details as filled by the institution on Council’s faculty module.
  - c) the institution submitted the list of 15 faculty members which reveals that -
    - 5 are not qualified to teach pharmacy subjects (MBBS, MCA, M.Sc.)
    - though the college was started in the year 2019, 3 faculty joined in 2021 and 4 faculty joined in 2020.
    - faculty which have joined in 2019, 2 are holding only B.Pharm qualification who are not eligible to teach B.Pharm and another remaining 4 holding M.Pharm qualification are also not having prescribed teaching experience as per the statutory provisions of “Teachers Regulations”. This clearly reflects that institution has failed to appoint the faculty as per the prescribed norms.
  - d) the details submitted with regard to equipments, chemicals and glassware were without GST and documentary evidence of bank transfer of purchase.
  - e) the institution failed to submit any documentary proof of bank transfer in respect of purchases made.
  - f) the photographs with regard to infrastructure were not Geo Tagged.
  - g) similarly no document proof has been provided for drinking water facility, gas connection is not provided instead commercial gas cylinder are used.
  - h) the institution was started in 2019 but the lease documents are of 2020 and 2021.

50.3 In view of above, it was noted that the course of study of this institution does not continue to be in conformity with the statutory provisions of -

- a) Education Regulations, 1991 for the Diploma course in Pharmacy.
- b) The Education Regulations, 2020 for Diploma Course in Pharmacy.
- c) The Bachelor of Pharmacy (B.Pharm) Course Regulations, 2014.
- d) Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014.

50.4 Considering the above, it was decided to -

- a) reduce the intake capacity by 20 seats in both D.Pharm and B.Pharm courses w.e.f. 2022-2023 academic session.

- b) institution be advised to -
  - i) rectify the deficiencies pointed out in the September, 2021 inspection report and PHC.
  - ii) submit compliance with documentary evidence along with a copy of Income Tax Return in respect of Principal and all teaching faculty since inception of the course within 10 days of receipt of the communication from PCI.

51.3 The institution be asked to submit the copy of Income Tax Return in respect of Principal and all teaching faculty since inception of the course.

**01.115.052:** Consideration of Findings and recommendations of PHC held on 13.12.2021 in respect of Tila Institute of Pharmaceutical Science, Ramgarh (Jharkhand)

52.1 The latest information on record was placed.

52.2 It was noted that -

- i) institution is running D.Pharm course with 60 intake from 2019.
- ii) Inspection Report of September, 2021 reveals that -
  - a) at the time of inspection, only one staff member was present against the requirements of 1 (Principal) + 7 (teaching staff). No documentary evidence with regard to consent of Principal and Teaching staff was available.
  - b) This clearly reflects that teaching staff and faculty cadre ratio as per prescribed norms was not appointed thus flouting the prescribed norms of "Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014".
  - c) the Principal of the institution informed that the college building is not as per the approved plan.
  - d) no instruments were there in labs.



- e) No gas connections to any laboratory.
  - f) No equipments were available. They failed to show the same, even after asking by inspectors.
  - g) only few chemical and glasswares were present in the laboratories and the chemical boxes were not opened.
  - h) student attendance was marked with pencil and seems to be fabricated.
  - i) sessional marks were allotted without evaluation.
  - j) Only one class room is having board.
  - k) machine room is of 100 sq. feet and without any machine in it.
  - l) The other infrastructure like Central instrumentation room, store room, museum, herbal garden, drinking water facility etc. are not as per the prescribed norms.
  - m) no qualified librarian is appointed.
  - n) one laboratory short. No preparation room and Lab. technician was available.
  - o) No documentary evidence for having conducted the classes was available.
  - p) Few books were placed in racks in waste storage room. No accession register was available.
  - q) no practicals held and attendance is fabricated.
  - r) In the admission register, the photos fixed were still wet at the time of inspection indicating they were freshly prepared.
  - s) other administrative areas was also not sufficient.
- iii) Institution was given an opportunity to appear before the Personal Hearing Committee (PHC) of the PCI on 13.12.2021. The findings of the PHC are as under –
- a) Against the requirement of 1 (Principal) + 7 (teaching staff), only Principal and 3 teaching staff appeared before the PHC.
  - b) joining report and relieving order from the previous employment was not submitted.
  - c) name of Principal is not reflected in PCI portal.
  - d) faculty is not paid as per prescribed norms.
  - e) institution failed to submit any documentary evidence with regard to transfer of salary through bank.
  - f) Land & Building is on lease but 'Lease deed' was not submitted. Only agreement was submitted. Building Plan is not approved by competent authority. Submitted photographs are not Geo Tagged.
  - g) Machine Room has not been developed as per norms with reference to photo submitted.
  - h) Details of Equipments - None of the documentary evidence was presented in support of procurement of equipments.
  - i) Purchase of deficient glasswares was not done.

- j) Proper Gas fitting is not available as per photograph/ documents submitted.
- k) Institution failed to submit the full compliance of the deficiencies pointed out in September, 2021 inspection with documentary evidence.

52.3 It was noted that the course of study of this institution does not continue to be in conformity with the statutory provisions of -

- a) Education Regulations, 1991 for the Diploma course in Pharmacy.
- b) The Education Regulations, 2020 for Diploma Course in Pharmacy.
- c) Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014.

52.4 In view of above, it was decided to -

- a) issue notice for withdrawal of approval of D.Pharm course under section 13 of the Pharmacy Act, 1948.
- b) the authorities concerned be advised not to make admissions in D.Pharm course from 2022-2023 academic session.
- c) the institution shall submit the copy of Income Tax Return in respect of Principal and all teaching faculty since inception of the course.
- d) to instruct the institution to forward its representation through the State Government within three months failing which Council shall be constrained to withdraw approval u/s 13.

**01.115.053:** Consideration of Findings and recommendations of PHC held on 13.12.2021 in respect of BLM School of Pharmacy, Distt- Deoghar 814114 (Jharkhand)

53.1 The latest information on record was placed.

53.2 It was noted that -

- i) institution is running D.Pharm course with 60 intake from 2020.
- ii) Inspection Report of September, 2021 reveals that -
  - a) During inspection, institution submitted the list of 14 teaching staff members but only 5 signed the list.
  - b) Out of 5, said staff members 4 have joined in August, 2021 and 1 in July, 2021.
  - c) The date of joining of Principal is also reflected as 19.7.2021.
  - d) This clearly reflects that teaching staff and faculty cadre ratio as per prescribed norms was not appointed thus flouting the prescribed norms of "Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014".
  - e) There is no gas connections in the laboratories.

- f) Insufficient electrical connection in all the labs.
  - g) There is no fire extinguishers.
  - h) Proper foundations for machines in the machine room was required to be provided.
  - i) Equipments are deficient.
- iii) Institution was given an opportunity to appear before the Personal Hearing Committee (PHC) of the PCI on 13.12.2021. The findings of the PHC are as under -
- a) the list of teaching staff submitted to PHC reveals that -
    - Only 05 faculty members out of 11 mentioned on PCI portal were present.
    - Salary to faculty is made through cash except for one person.
    - prescribed payscales are not implemented.
  - b) Valid 'Lease deed' from competent authority is not submitted.
  - c) Only 01 Gas cylinder for entire institute/ school.
  - d) Fire extinguishers have not been installed.
  - e) Payments of purchase of equipment, chemicals, books etc. was not made through bank/ RTGS.
  - f) Electric load has not been enhanced till the date.
  - g) Submitted photographs are not geo tagged.

53.3 In view of above, it was noted that the course of study of this institution does not continue to be in conformity with the statutory provisions of -

- a) Education Regulations, 1991 for the Diploma course in Pharmacy.
- b) The Education Regulations, 2020 for Diploma Course in Pharmacy.
- c) Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014.

53.4 Considering the above, it was decided to -

- a) reduce the intake capacity by 20 seats in D.Pharm course w.e.f. 2022-2023 academic session.
- b) institution be advised to -

54.1 The latest information on record was placed.

54.2 It was noted that -

- i) institution is running -
  1. D.Pharm course with 60 intake from 2019.
  2. B.Pharm course with 60 intake from 2019.
- ii) Inspection Report of September, 2021 reveals that -
  - a) During inspection only 1 teaching staff was present.
  - b) a list of 9 teaching staff members was submitted to inspectors, perusal of which reflect that –
    - qualification of none of the teaching staff reflected.
    - out of 9, 7 was fresh without teaching experience and 2 were have only 2 years experience.
  - c) the Principal shown in institution’s application called Standard Inspection Form (SIF) was not working at the time of inspection. The Principal was appointed on 2.8.2021.
  - d) This clearly reflects that teaching staff and faculty cadre ratio as per prescribed norms was not appointed thus flouting the prescribed norms of “Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014”.
  - e) equipments were deficient in nearly all the laboratories.
  - f) details of classes held during 2019-2020 in respect of B.Pharm course was not available.
  - g) Journals were not available.
- iii) Institution was given an opportunity to appear before the Personal Hearing Committee (PHC) of the PCI on 14.12.2021. The findings of the PHC are as under –
  - a) only Principal appeared before the PHC. No other teaching staff reported though institution was specifically asked that Principal along with the teaching faculty shall appear before the PHC.
  - b) institution failed to submit any documentary evidence in the form of photographs with regard to infrastructural facilities as to whether building is own / rented, laboratories, lecture halls, machine room, furniture, store room etc.
  - c) institution also failed to submit documentary proof of having made payment with regard to purchase of equipments, chemicals, glassware etc.
  - d) no proof of gas connection and availability of portable water was submitted and availability RO for portable water was submitted.

54.3 It was noted that the course of study of this institution does not continue to be in conformity with the statutory provisions of -

- a) Education Regulations, 1991 for the Diploma course in Pharmacy.
- b) The Education Regulations, 2020 for Diploma Course in Pharmacy.
- c) The Bachelor of Pharmacy (B.Pharm) Course Regulations, 2014.
- d) Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014.

55.2 It was noted that -

- i) institution is running -
  1. D.Pharm course with 60 intake from 2018.
  2. B.Pharm course with 100 intake from 2021.
- ii) Inspection Report of September, 2021 reveals that -
  - a) Principal was not present during inspection. Also there is no clarity with regard to name of Principal.
  - b) out of 13 staff members indicated in the SIF, 9 were absent during inspection.
  - c) This clearly reflects that teaching staff and faculty cadre ratio as per prescribed norms was not appointed thus flouting the prescribed norms of "Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014".
  - d) For B.Pharm course, no additional class rooms, laboratories, equipments and glass wares etc. were available.
  - e) some equipments are deficient.
  - f) the books are available for D.Pharm course but not for B.Pharm.

- iii) Institution was given an opportunity to appear before the Personal Hearing Committee (PHC) of the PCI on 14.12.2021. The findings of the PHC are as under –
  - a) Principal joined in October, 2021.

- i) Attendances for theory classes for 2020-2021 students were not updated after April 2021. Students and teachers orally informed that theory classes for the students of Noorie College of Pharmacy and Aristotle College of Pharmacy were conducted in Golden College of Pharmacy by clubbing them.
- j) No students for Pharm.D were admitted for 2020-2021 academic year. No D.Pharm IInd students were not available. For IIIrd semester B.Pharm, proof of course curriculum coverage not available.
- k) No practical note books of students were available.
- l) No practical record was found. No chemicals have been used for the past one year.
- m) In SIF, claims 23 labs but having only 9 labs.
- n) Claimed 80 sqm. animal house but not available. Claimed to have conducted the classes as per norms but no documentary evidence available.

  - r) The Inspection panel have serious doubt on existence of building of Pharmacy College.
  - s) Institute/college made false claim in the online SIF submitted to PCI.
  - t) The college did not submit any evidence of online theory and practical classes to inspectors.
  - u) The inspectors specifically pointed out that the college does not continue to be in conformity with the educational standards of D.Pharm and B.Pharm as prescribed by the PCI.
