02.332.008: Consideration of approval for B.Pharm and M.Pharm in respect of Dept. of Pharmaceutical Technology, Jadavpur University, 188, Raja S.C. Mullick Road, Kolkata – 700 032 (West Bengal).

- 8.1 The latest information on record was placed.
- 8.2 It was noted that 327 EC (30th April, 2020) under Item No.107 has decided that existing approved institutions which did not apply online during 2020-2021 be considered for approval for 2020-2021 academic session provided they pay double the affiliation fee as penalty.
- 8.3 Since above institution is an existing institution and hence covered in Council's said policy decision of 327 EC. In view of it, it was decided to extend this opportunity to this institution and if the institution agrees to this condition to pay double fee, approval be granted.

24.2 It was noted that -

- a) during 2019-2020 also the institution applied to PCI for starting of 1st year D.Pharm course based on the affidavit that the institution will submit the consent of affiliation of Examining Authority before making admissions but it failed to submit the consent of affiliation of Examining Authority.
- b) now again during 2020-2021 also the institution has again submitted an affidavit that it will submit the consent of affiliation of Examining Authority before making admissions.

24.3 In view of above, since the Council cannot go on giving the approvals every year to the institution based on the affidavit without submission of affiliation of consent of Examining Authority, it was decided to reject the application for D.Pharm course.

25.1 The latest information on record was placed.

25.2 It was decided to intimate the institutions that -

- a) as per various regulations framed u/s 10 of the Pharmacy Act, the Examining Authority shall either be a statutory Indian University or a body constituted by the Central or State Government.
- b) consent of affiliation of an Examining Authority is pre-requisite for consideration of an application for approval of pharmacy course under the Pharmacy Act, 1948 and the institutions desirous of approval shall submit the affiliation of an Examining Authority and PCI has no role in it.

25.3 In view of above, it was decided to instruct the institutions which submitted the consent of affiliation of Aryabhata Gyan Vishwavidayala to produce the consent of affiliation of Examining Authority within 2 weeks of issuance of the letter failing which the approval if earlier granted by the Council will be deemed to have been withdrawn.
