- ii) Institutions running D.Pharm./B.Pharm./Pharm.D & Pharm.D (PB)/Bachelor of Pharmacy(Practice)/Master of Pharmacy courses simultaneously have to pay separate DDs for each course(s).

 - Degree file number starts with 32-
 - Pharm.D & Pharm D. (PB) file number starts with 50-

 - Bachelor of Pharmacy (Practice) Course file number starts with 70-
