- 3, COMPUTER, PRINTER, UPS, INTERNET 2MBPS (Computer Spec- i3 3rd to 6th gen. Windows 7 to 10, 4gb Ram, 500gb hard disk, Printer- Epson lx310 or Any laser printer)
- 4,Phramacist B.phrm/D.phrm Licence certificate Photocopy
- 5, Blue print of the shop and recently paid Tax receipt of shop
- 6, TWO PHOTO OF PROPRIETOR
- 7, 3 AGREEMENT (Rental agreement in 10/- rs Stamp paper, Declaration Agreement from pharmacist in 10/-, Agreement between proprietor and Bppi in 100/-rs Stamp paper)
- 8, After getting DL, agreement copy original & DL photocopy should send to the head office Delhi and get final approval
- 9, After final approval, software will be installed in your system via online with the help of Marketing Officers and drug's will be given by TamilNadu Distributor with 30 days PDC (post dated check)
